### **HOW TO REGISTER YOUR CHILD FOR THE BUS SERVICE:**

A copy of the Application form is included in the RVIS Admission Package. Please complete the required fields and ensure that you provide a location map and exact address with your application. Applications without an address and/or contact information cannot be entered into the database.

You may also pick up an Application form from the RVIS Business Manager located in the Central Administration office during regular school hours. One application is required per family. Additional siblings can be added in the Student Information section of the form.

### **CANCELLATION OF SERVICES AND WITHDRAWALS:**

In the event of a cancellation of bus service for your child for any reason, parents are required to notify the RVIS receptionist AND the Al Hutaim Office as early as possible.

### **METHOD OF PAYMENT AND INVOICING:**

- Check/Cash payment only accepted. Please make checks payable to: **AL HUTAIM**
- Please ensure that you request a receipt as proof of payment.  
Charges applied; providing that the company submits a letter of approval for payment.
- Employer corporate accounts are asked to provide the Al Hutaim office with a list of students that will be billed directly to their office rather than invoicing parents for the bus fees. In such cases, we will require a company contact person, their address and telephone number for follow up on payments and updated lists.

### **FURTHER INFORMATION:**

Prior to the beginning of service, you will receive specific information about pick up and drop off times, and your child's bus number. All information will be sent directly to your house. If delivery is not provided, we will be contacting you by phone. Please feel free to contact our staff at any time if you require further information.

In the event that you have not received any busing details three days prior to the start of service, please contact our office at 1740 0159 and ask to speak to the Bus Transportation Office. We may be in need of your correct or complete contact information to update our records.
